INSULBREAK, PERMIFLOOR and PERMISHIELD are fibre-free, thermo reflective insulation, comprising a cross-linked, closed-cell foam core sandwiched with an anti-glare foil facing on one side and a plain foil facing on the other side.

PERMICAV XV is a micro-perforated, fibre-free. thermo reflective insulation, comprising a cross-linked, closed-cell foam core sandwiched with an anti-glare foil facing on one side and a plain foil facing on the other side.

PERMIWALL is a fibre-free, thermo reflective insulation, comprising a cross-linked, closed-cell foam core sandwiched with a plain foil facing on both sides.

RETROSHIELD XL is fibre-free, thermo reflective insulation, comprising a cross-linked, closed-cell core sandwiched with a plain foil facing on both sides.
